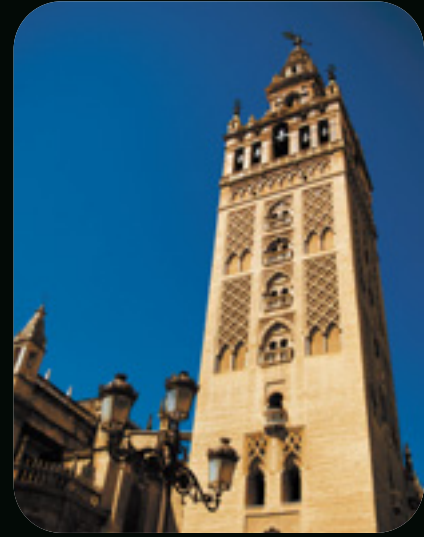

CUSTOMS FORMALITIES & DOCUMENTATION FOR GOODS ARRIVING FROM OVERSEAS

All customs formalities have to be done at the fairground.

During the exhibition, goods remain under Spanish customs control in temporary importation.

At the end of the show the goods can either be :

1. sent back to the shipper
2. definitively cleared through customs if they are sold in Spain with payment of duty and taxes

No goods can leave the fairground without carrying out one of those formal procedures.
